**Explanation of Responses:**

- (1) Each Restricted Stock Unit ("RSU") represents a contingent right to receive one ordinary share of GAN Limited or the cash equivalent of such share.
- (2) RSU's settle on the basis of 25% each calendar quarter during continued service, with all RSU's settling on the anniversary of the date of grant.
- (3) The RSUs were issued as director compensation.

**Remarks:**

This Form 4 is amended for the purposes of (1) reflecting the grant of the 5,179 RSU's rather than a grant of restricted stock awards, and (2) correcting the number of Ordinary Shares beneficially owned by the reporting person as reported in Column 5 of Table I.
